The Organization is also implementing an integrated management system between the UNI EN ISO 9001: 2015 and UNI ISO 45001: 2018 standards, with the aim of obtaining UNI EN ISO 45001 certification in the near future, issued by an accredited third party.

M.P.I. considers the UNI ISO 45001: 2018 and the Consolidated Law on Health and Safety as the guidelines which all the company's choices on occupational health and safety should be inspired by and comply with. We believe integration among standards is the adequate tool that will allow us to assure better management of the Company's most strategic aspects as well as of our Employees' Health and Safety. These activities will assure the essential support to the company to achieve continuous growth in its target markets. Not only M.P.I. as a company but all its stakeholders will benefit from this as well.

Over the years, M.P.I. has arranged its structure, its personnel and facilities in order to assure tailor-made services to our Customers such as:

- technical support in the Customer's design stage, also by using appropriate simulation software;
- standard or specific magnet inspections on request;
- possibility of re-magnetisation on site;
- storage of the material at our warehouse;
- assistance in bureaucratic fulfilments.

Among the mandatory regulations we adhere to REACH registration, which is for us fundamental, because it is the most important regulation about chemicals ever released Europe-wide. M.P.I. has ended the registration in May 2018.

At company level, we respect the environment by performing proper waste separation and what is more, back in July 2012 we installed photovoltaic panels to produce clean and renewable energy.

- ✓ assure the Company's success and the satisfaction of its Employees and stakeholders;
- ✓ Continuous training of M.P.I. personnel in terms of Quality, Safety and Environment, making employees aware of their individual obligations and of the importance of all their actions for achieving the expected results and of their responsibility within the QMS as well as on occupational health and safety;
- ✓ the achievement of the "performance" objectives set in the annual Improvement Plan;
- ✓ definition of reachable and measurable objectives concerning the Occupational Health and Safety System;
- ✓ implementation of the planned activities for the year;
- ✓ the System Integration with the Security System according to the BS OHSAS 18001: 2007 Standard;
- ✓ drawing up, disseminating and keep up-to-date management and operative procedures for constantly monitoring the QMS and OHSMS;
- ✓ developing programmes, objectives, goals and assuring adequate human and economic resources to achieve them;
- ✓ undertaking to define rules of conduct and work procedures suitable to reducing occupational accidents and diseases;
- ✓ raising the awareness of contractors and suppliers, from whom to expect compliance with this policy, the laws and safety procedures implemented by the company;
- ✓ periodically perform a review of this policy to assess and assure its consistency, adequacy and appropriateness to the organisation, the effectiveness of its performance and to make it possible to reformulate continuous improvement goals.
